## **IREKA ENGINEERING & CONSTRUCTION SDN BHD WINS RM163.9M CONTRACT FROM REGENCY SPECIALIST HOSPITAL SDN BHD**

**Kuala Lumpur, 29 June 2020:** Ireka Engineering & Construction Sdn Bhd ('IECSB'), the Construction arm of Bursa Malaysia Main Market-listed Ireka Corporation Berhad ('Ireka'), has been awarded a contract by Regency Specialist Hospital Sdn Bhd in Johor for works on the main building and completion of a 10 storey hospital extension block worth RM163.9m. The project will commence on 1 July 2020 and is expected to complete in 18 months.

The construction works will include car parks, medical facilities, the main lobby, hospital facilities, hospital wards and medical suites. The Regency Specialist Hospital project is expected to contribute positively to the earnings of Ireka Group for the financial year ahead.

Commenting on the Contract award, Ireka's Group Managing Director, Datuk Lai Voon Hon said, ***"We are delighted and proud to have won this contract. As the Government pushes ahead with increased healthcare expenditure, Malaysia's healthcare market is projected to grow. The Regency Specialist Hospital contract is an opportunity for Ireka to build on its own track record of hospital construction (e.g. City International Hospital, Ho Chi Minh City, Vietnam). The Group will also continue to leverage on its 53-year track record and the skilled multi-disciplinary***

***team within Ireka to ensure that it is well positioned to tender for more upcoming projects.”***

Ireka’s current major projects include KaMi Mont’ Kiara, a residential project in Mont’ Kiara; Asta Enterprise Park in Kajang, and Rimbun Kasia, a development project consisting of 5 parcels in Nilai, Negeri Sembilan.

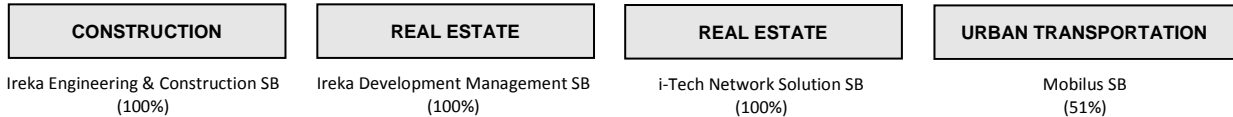
